# MEMBERSHIP RIGHTS AND BENEFITS

## Governance Rights

1. VEA/NEA-Retired members are entitled to voting representation on the VEA and NEA Boards of Directors; they also elect voting delegates to the state and national Representative Assemblies.
2. In Virginia, local education associations are encouraged to provide representation to VEA/NEA-R members on all appropriate committees and local governing bodies.

### 2. Legal Services

- Attorney Referral Program

This program provides legal assistance for personal matters such as wills and estates, real estate, domestic relations, consumer protection, and traffic violations. In any membership year, you are entitled to two 30-minute consultations with an Association attorney and if you choose to retain the attorney you also will receive a 30% discount in the attorney's hourly fee. This program also extends to anyone in your immediate family.

- Educators' Employment Liability Program

This policy provides you with \$1 million worth of coverage for lawsuits brought against you in the course of your duties as an educator.

**A Note to members who have retired but have chosen to return to part-time or full-time teaching in a special program:** VEA-R membership was not designed nor priced for members who are employed either on a full-time or a part-time basis. VEA-R membership provides only limited UniServ assistance and does not cover the member for employment-related problems. Thus, if you are teaching on a full or part-time basis, you may want to become an Active Member in order to make use of your UniServ Director's expertise or to participate in the VEA/NEA Legal Services Program (*Kate Frank-Dushane Program*).
